SUITABLE SAFEHOUSE PACY CITY AREA. BEST PROSPECTS ARE FURNISHED
HOMES RENTED FOR 60-90 DAY PERIODS BY PERSONS VACATIONING ABROAD. BECAUSE

OF LOCAL PERMITS RENTER SHOULD BE LOCAL STAFFER SUCH AS CORNELIUS
