<p>REFERENCE: UFGA 5212, 13 August 1962</p> <p>1. SUMMARY - This period has been a very active one for AMDENIM 1 as for all PBRUMEN exile patriots in that the build up of Soviet strength in PBRUMEN has shown the need for more intensive work if the job is to be done. Subject has continued to exploit his knowledge and contacts who have operational potential and has produced a number of ideas and candidates who are in various stages of development. He continues to be helpful in any way he can and steadily becomes more capable as a principal agent type. The question of whether or not to put him into the AMBUD 1 organization remains pending in view of the larger issue of what specific use is to be made of that organization.</p> <p>OPERATIONAL DEVELOPMENTS</p> <p>2. Following word from AMDENIM 1 that he was at one time a close friend of Jose Llanusa, the head of the PBRUMEN delegation to the Jamaican Games, an attempt to make contact with Llanusa at the Games was authorized. The results were that Llanusa was completely inaccessible by the time AMDENIM 1 arrived in Kingston as a result of defection inroads already made in his delegation. Following his return AMDENIM 1 provided a legal traveler from the Santiago de Cuba area (Subj. of WAVE 7409) who was turned over to the FI Branch who obtained considerable intel and operational information from him before dispatching him with SW pencils to pass on to two of AMDENIM 1's contacts in Oriente. Throughout the period AMDENIM 1 has been on the look out for contacts for the ADDER team in the target area. Two separate efforts in this direction were to no avail due to either overly involved commo plans or crossing of operations. He has now come up with a legal traveler from the area who appears to be able to provide the assistance necessary to successfully infiltrate the team.</p>

<p>34 Subject's search for radio operators resulted in four candidates by the end of the period. Two are beginning training, one was unsuitable and the other is currently closing out his job before entering training. [Guillermo MASCARO], an AMDENIM 1 radop previously trained and held for use with the First UR exfiltrate who would reinfiltate, was called into service to join AMSTASH 1. This resulted in [MASCARO's] finally backing out, in his words, for want of PBRIME policy and plans re PBRUMEN, but in the C/O's opinion for want of courage, which belief was not withheld from him. The search for radops continued and AMDENIM 1 indicated at the end of the period that he had some eight further prospects including several women. They are currently being processed.</p>		
<p>4. In support of other Station interests AMDENIM 1 has spent considerable time preparing a study of strategic places in eastern PBRUMEN where the blowing of approximately five bridges would serve to divide the country into two parts and prevent the troops in one part from rapidly coming to the aid of troops in the other part. These efforts have been forwarded to Intel Support for development. He has also been on the lookout for fisherman leads which could be developed into ratlines for infiltrating agents and materiel. Two such leads appear very worthwhile, one is being utilized by the SHATTER Team and the other will probably be used by one of the Las Villas teams in preparation. He used AMLION 1 to good advantage in developing these leads and continues to look for others while AMLION 1 is assisting in the training of the SHATTER Team fisherman as interpreter.</p>		
<p>5. The internal asset AMEPOCH 6 whom AMDENIM 1 developed thru a legal traveler who carried in an SW system, has now been contacted thru a YELLOWTAIL III sea rendezvous and is being prepared to receive an initial increment of the LYRE team for relay into the Matanzas area. It is hoped to make AMEPOCH 6 a ratline for the remainder of this team and the materiel they will require to carry out their operational tasks. See UFGA-6159 for the YELLOWTAIL III After Action Report on the sea rendezvous.</p>		
<p>6. Just before the end of the period AMDENIM 1 reported that AMDENIM 11 supposedly had word of an imminent uprising on behalf of Rebel Army officers in three provinces. Considerable effort was devoted by the Station to running this lead down only to find that AMDENIM 11 was involved with at least one other group which was trying to obtain ODYOKE support and that AMDENIM 11 had actually had contact with GPFOCUS several days beforehand. The case broke on the basis of AMDENIM 11's withholding info on this contact and having lied about his activities at YOACRE where he claimed to have gone out of the fence with the help of ODOATH personnel to contact the movement's leaders. Although AMDENIM 11 was terminated as a result of not coming clean, there now appears to have been at least a half-hearted attempt throughout the country to mount an uprising at approximately the same time. Its dimensions do not appear to have been significant. Unfortunately whatever potential AMDENIM 11 had was destroyed by his unwillingness to level with us. It should be noted that AMDENIM 1 merely passed the lead to us for what it was worth and at no time expressed any real credence in the story nor endeavored to obtain action on the basis of it.</p>		
<p>INTELLIGENCE PRODUCTION</p>		
<p>7. UFG 1619, Subject Cuban Arms for Columbia is the only AMDENIM 1 report which was disseminated.</p>		
<p>8. Throughout the period AMDENIM 1 provided spot reports on possibly significant developments within the exile community and the AMBUD 1 organization. These included such items as the DRE raid on Havana, the Manolo Rev meeting in Puerto Rico, the URIS difficulties in getting into the AMBUD 1 organization, Alpha 66, Jerry Patrick Hemming, and his recommendations re reorganizing the AMBUD 1 organization and the maritime situation. He follows the direction of the Case Officer and does not allow his disappointment at the slow pace of developments towards liberating PBRUMEN to interfere with his work for us.</p>

<p>Service was performed for AMDENIM 1 in response to his request for assistance in obtaining a re-entry permit for his Spanish maid who desired to visit her dying mother in Spain and had not been able to get thru ODURGE red tape on her own. The matter was taken care of in less than 36 hours and went a long way towards convincing AMDENIM 1's family that his absences from home at all hours was not without its advantages.</p>														
<p>10. PLANS - The intention at present is to proceed with AMDENIM 1 in the same terms indicated above. The possibility continues for expanding his role of supplying the Station with information on community activities, operational leads and as front man for activities not sufficiently jelled to expose Station personnel by making him action coordinator within the AMBUD 1 organization. This hinges on decisions yet to be made as to just how the organization is going to fit into future plans. In the meantime AMDENIM 1 will continue to be used as before with emphasis being placed on the development of leads for ratlines to be incorporated in the Fisherman operations and teams with radio operators to take advantage of the ratlines.</p>
