- 3. LIHUFF/l believes, however, that Identity B would be willing to leave a liaison office in Mexico City--responsible for Mexico and Central America--if this were requested by LIHUFF/l and if RABIDA and/or KUBARY would also see Identity B to advise him of LIHUFF/l's usefulness to the two (2) organizations.
- 4. It is requested that Identity C be contacted by the Mexican Desk and asked if he can see Identity B on this problem.
- 5. LIHUFF/l has inmigrado papers; he was, as is known to Head-quarters, born in Mexico.
- 6. In answer to the last question of reference, Mexico City Station would insert another cut-out between the Station and LIHUFF/2 if LIHUFF/1 should leave Mexico. The long and friendly relationship which exists between LIHUFF/1 and LIHUFF/2 would not be replaceable.
- 7. The Station would appreciate being advised of the results of action requested in this dispatch.
