Dear Mr. Hobbing:

My memorandum to you concerning the financing of a group in Mexico for the expressed purpose of fighting Communism in Mexico has been forwarded to you through separate and confidential channels.

I also understand there is an interest in this project however you require more details. In this regard I believe a personal discussion seems to suggest itself as the means most viable to clarify and elaborate on these details.

If this suggestion meets with your approval I can meet you most any time in Mexico City; however with advanced planning and notice I can meet you in some city in the U.S.. Please advise. I personally believe that a meeting outside of Mexico would be preferable, perhaps New Orleans or Miami.

I also understand there is some concern on your part as to whether or not Ambassador Lamm would consider your financing this group as, "American meddling in local politics.". I assure you that methods can be devised which would not only overcome this objection but would also bring your efforts within the official classifications of the Ambassador.
