1. LICOOKY EVENING 4 APR TURNED OVER TWO COPIES COMPLETED (LINLUCKY) PAMPHLET. IN WRITTEN REPORT FROM HER DATED 4 APR SHE SAID RAUL OSEGUEDA IN MEXI AND SAID (LINLUCKY) PREAM IN NOVEMBER HAD CAUSED "RESTRICTION" IN VENEZUELA. SHE SAID HE VERY ENTHUSIASTIC ABOUT PAMPHLET AND SAID MANY WRITERS HAD ASKED HIM FOR COPIES OF THE ARTICLES BUT HE HAD NOT BEEN ABLE OBTAIN THEM EVEN FOR HIMSELF. HE PRAISED (LINLUCKY) FOR HAVING COURAGE TO SPEAK OUT AND EMPHASIZED IMPORTANCE OF (LINLUCKY) BEING BOTH CULTURED AND HAVING RECORD OF ACTION. OSEGUEDA TOOK A FEW COPIES OF PAMPHLET WITH HIM TO SEND IMMEDIATELY TO CARA. SAID HE MAY BE GOING BACK TO CARA AND IF WE WOULD LIKE TO TAKE PACKAGE WITH HIM. LICOOKY IN EXTREME HURRY AT CONTACT (DUE NEED CATCH BUS TO BORDER TO RENEW HER DOCS) AND DID NOT PROVIDE ANY DETAILS RE PAMPHLET DISTRIBUTION, WHETHER SHE HAD SAVED COPIES TO (LINLUCKY), OR WHETHER HAD RCVD PARA TWO MONEY ORDER. CHECK BOOKSHOPS 5 APR BY STATION ASSETS FAILED LOCATE PAMPHLET SO APPARENTLY NOT YET DISTRIBUTED. WILL FWD COPIES ALL ADDRES WHEN AVAILABLE. POUCHING ONE COPY HAS ONLY NEXT POUCH.
