1. QJWIN HAS CULTIVATED CLOSE PERSONAL RELATIONSHIP WITH IDEN A WHO AGREED SHUGGLE INDUSTRIAL DIAMONDS FOR HIM TO ITALY. QJWIN HAS PROMISED HIM REMUNERATION.
2.
