INFORMANTS

On 1/27/67, HO 1084-C, Aransas Pass, Texas, advised CLIFTON JOHNSTON, JR., was known to her, but she did not know his present whereabouts or how to reach him.

On 1/23/67, HO 1180-C, Aransas Pass, informed he is well acquainted with CLIFTON JOHNSTON, JR., who was at that time on a fishing trip in the Gulf of Mexico, and who would no doubt return to Aransas Pass shortly.

On 1/27/67, HO 1180-C furnished information that CLIFTON JOHNSTON, JR., was at that time at the Beach Grill at Conn Brown Harbor. JOHNSTON was thereafter located at that place, which is owned and operated by HO 1180-C.
