LEE HARVEY OSWALD

All sources utilized in this memorandum and its appendix have furnished reliable information in the past.

On March 16, 1964, a confidential source advised as follows: LA -4107-S

On February 28, 1964, MARK LAWE, attorney for the mother of LEE HARVEY OSWALD, spoke in Buffalo, New York, address unknown, at a meeting organized by Buffalo members of the Workers World Party (WWP) (see appendix). The source did not know the topic of LANE's speech.

According to this source, a committee, name unknown, has made necessary arrangements for LANE to speak at the Embassy Auditorium, Los Angeles, on April 3, 1964. SAM MARCY, National Chairman of the WWP, gave recent telephonic instructions to LOUISE MERRILL, Los Angeles Branch-WWP (LAB-WWP) (see appendix) Organizer, for the LAB-WWP to cooperate completely with and lend all possible assistance to the committee arranging for LANE's Los Angeles speech. The LAB-WWP will prepare mimeographed announcements of the forthcoming speech. Source also advised that DEIRDRE GRISWOLD, a member of the WWP National Committee, works closely with LANE and LANE's office.
