### PCM-PPS. State of Coahuila

Informant advised that there is no PCH or PPS organizations or activities in Ciudad Acuna. Informant stated that the leader of the PPS in Coahuila, CASIANO CAMPOS, had not recently visited in Ciudad Acuna and that the nephew of CAMPOS, ROBERTO LOBO, who is a selfadmitted member of the PPS, has not conducted any activity on behalf of the PPS although he has been in Ciudad Acuna much of the time during the past two months. Informant stated he knows of no subversive groups in the border area of Coabulla and no attempts by any subversive group to organize in that area.
