CUBAN MATTERS - COUNTERINTELLIGENCE PROGRAM IS - CUBA Buded 9/11/61

Rerep of SA John R. Wineberg dated 8/21/61 entitled "Miguel Salvador Morera, aka, IS - Cuba, RA - Cuba." Information appearing on pages four and five of referenced report shows PH 563-S possesses information indicating Morera feels one of the members attending a meeting of the July 26th Movement in Philadelphia on 8/5/61 was not fully trusted. Referenced report reveals there were only seven persons present at that meeting, including Morera and the informant.

Determine from PH 563-S and any other sources available to your office identity of all July 26th members in attendance at the mentioned meeting. Fully identify individual believed to be untrustworthy by Morera. In the event you have no pending investigation regarding that individual, institute same immediately and fully determine his background and degree of activity in July 26th Movement in Philadelphia.

The element of distrust in one of his followers evidenced by the new leader of the July 26th Movement in Philadelphia provides an excellent opportunity to create disruption and dissension within the ranks of the pro-Cuban organizations in Philadelphia. An aggressive counterintelligence program directed against the weak point evidenced by Morera's distrust should be immediately instituted.

Sulet by 9/11/61 incorporating identity of individual suspected by Morera and positive recommendations for action by your office to seize this opportunity for institution of a counterintelligence program against the pro-Cuban element in Philadelphia. Take no action to implement such a program prior to Bureau authority for same.
