On February 27, 1964, Mr. WALLACE SHANLEY, Assistant Customs Agent in Charge, Miami, advised that the U.S. Border Patrol has previously served FRANK FIORINI and WILLIAM JOHNSON notices of Preventure of Departure. These notices are to prevent FIORINI and JOHNSON from going to Cuba and do not apply to other countries. SHANLEY said that FIORINI and JOHNSON have requested Customs' permission to go to Central America, but Customs had no authority to stop them, and the Border Patrol and the U. S. State Department have no objection to their going. SHANLEY said he will search the airplane before they leave the United States to ascertain there are no automatic weapons or articles of war on the aid
