- 1. LITAMIL 9 REPORTED 27 NOV AFTER SILVIA DURAN FIRST ARREST WAS PUBLIC KNOWLEDGE THAT THERE GREAT DEAL DISCUSSION OF THIS IN EMBASSY. SHE BACK IN OFFICE 25 NOV AND SEEMED QUITE PLEASED WITH HER PERFORMANCE. HER ACCOUNT INTERROGATION CONTAINED LITTLE NEW EXCEPT POLICE HAD THREATENED HER WITH EXTRADITION TO U.S. TO FACE OSWALD. SHE HAD NO FEAR OF CONFRONTATION. L-9 DESCRIBES HER AS VERY INTELLIGENT AND QUICK WITTED.
