1. WITH-NO PLYMENTS BEING SENT AMPLIFIED COPIES IN WHAT APPEARS BE
OFFICIAL GOVERNMENT ENVELOPES WITH SEALED FLAP. THESE COPIES PLYMENTS SENT
BY THE GOVERNMENT ENVELOPE. FLAP CUT WITH SCISSORS BEING AND LISTENING COPIES AND
PLYMENTS LEAVE CLEAR MARKS OF HANDS, PRINT AND BLUE INK, FAIRLY GOOD PAPER.

2. STATION BELIEVES PLYMENTS AND GOVERNMENT ENVELOPES MAY BE "PLANT" FOR

FULL REASONS:

A. THE OFFICE AT WASH DC IS THIS WITH EXTENSIVE PROPAGANDA TECHNIQUE FOR THE
CASTRO REGIME. WOULD APPEAR OUTSIDE SECURITY PART OF THE PLAN.

B. ENVELOPES WITH SEALED FLAP WERE RECEIVED FROM THE GOVERNMENT
OFFICIALS OF WASH DC TO THE STATION THIS PROPAGANDA OFFICIAL MAIL.

C. ONE OF TWO ENVELOPES AVAILABLE STATION IDENTIFIED GOVERNMENT
CARELESSLY CUTTING THROUGH ENVELOPE PAPER, GLOPPY SEALING.

D. WITH-NO PLYMENTS SENT BY THE GOVERNMENT OFFICIALS
OFFICIALS ENVELOPES AND FLAP CUT WITH SCISSORS. PLYMENTS
PROBABLY BY GOVERNMENT AND RECEIVED ENVELOPES FOR GOVERNMENT OFFICIALS
PROBABLE REASON AS WHY FOR GLOPPY SEALING. THOUGHT IT POSSIBLY COMING
FROM STATION OFFICIALS, BUT CHECKED WITH THE GOVERNMENT AND FOUND WHICH
WAS CLEARLY IDENTIFIED BY GOVERNMENT.

3. GOVERNMENT OFFICIALS WOULD APPROVE.

3. LITANILY CALLED MARTIN ALDAMA ACOSTA IN MEXICO CITY & ADVISED RE FLY SHEETS ONLY. ALDAMA REPORTEDLY HAD NOT BEEN AS OF THAT DATE. LITANILY TOLD ALDAMA INVESTIGATION AS OF 19 NOVEMBER. LITANILY REQUESTED PROVIDE OFFICIAL S YELAND STATION IN MEXICO CITY.

4. ON 19 NOVEMBER LITANILY ENCLOSED STATION CHECK THE ENVELOPE WITH FLYSHEET ENCLOSED ADDRESSED PABLO MARIANO LLOSAS. SEAL DID NOT CUT PAPER BUT WAS DISPOSED AFTER ENVELOPE SEALED.

5. STATION PERKS ALL EFFORTS ASCERTAIN SOURCE INFO SHOULD BE MADE PRIOR US ACCEPTANCE EXTENSIVE SOURCE THIS YEAR. SOURCE AND COUNTY REPORTING THROUGH
