Dear Mr. Aly:

The Assassination Records Review Board is continuing its review of materials compiled by the House Select Committee on Assassinations (HSCA) and which, for various reasons, have not yet been made public. The Board is obligated to refer such records to the originating agency prior to releasing them. (You will recall that I referred an earlier batch of HSCA records to you in my letter of December 1, 1995.)

I am enclosing a new group of nine classified HSCA documents for your review. Please note that the grounds for postponing the release of information in the documents under Section 6 of the JFK Act are more restrictive than those allowed by the Freedom of Information Act. If you recommend that a document not be released, either in part or in its entirety, please provide whatever evidence you wish to present to the Board in support of the postponed release of information not later than February 22, so that the Board can review these documents at its meeting on February 29-March 1, 1996. I am attaching a form that should facilitate your response.
