Re: US Army Photos of 1967 Reinterment of President Kennedy

Dear Mr. Aly:

Staff members for the Assassination Records Review Board recently discovered several documents in the National Archives suggesting that the US Army had two photographers present for the March 14, 1967 reinterment of President Kennedy at Arlington National Cemetery. These two individuals were present on the instructions of then-Army General Counsel Alfred B. Fitt, who ordered them to photograph this event (which was closed to the general public) and deliver to him all prints and negatives the following day. According to other documents, forty-eight prints and negatives were in fact made and turned over to Fitt on March 15, 1967. We are unaware of the current whereabouts of those photos.

Any photos of the reinterment constitute assassination-related materials under the criteria set forth in the John F. Kennedy Assassination Records Collection Act, 44 U.S.C. § 2107, and should be forwarded to the National Archives for inclusion in the JFK Collection.

We request that you undertake whatever actions are necessary to determine where these photos are presently located and have them delivered either to the Review Board or to Mr. Steve Tilley, curator of the Archives' JFK Collection. In either case, we request that you keep us apprised of your efforts and progress. To assist you in your search, I am enclosing copies of four documents that establish the earlier existence of these photos and their last known location in the custody of former Department of the Army General Counsel Alfred B. Fitt.

- 1. Memorandum for Record dated March 2, 1967, re: "Reinterment of President John F. Kennedy." [Page 4, item 4a: "It is recommended that official photographs be made of the reinterment. These photographs would provide a historical record that would be valuable to the national interest. The film should be classified with the utmost care."]
- 2. Memorandum dated March 7, 1967 from Alfred B. Fitt to Major General Frank Sackton, Secretary to the General Staff. [Item 2: "An Army photographer should be present and active from 1700 until the event is complete. One set of prints only is to be made, and all prints and negatives should be delivered to me the following day in a sealed package. . ."]
- 3. Certificate dated March 14, 1967, signed by Major General Curtis J. Herrick, USA, affirming that "on the occasion of the reinterment at the Kennedy grave site, forty-eight (48) Polaroid prints were made and the same number of negatives processed for permanent use."
- 4. Receipt dated March 15, 1967 signed by Alfred B. Fitt acknowledging receipt of a sealed package containing forty-eight Polaroid prints and negatives of the reinterment.
