Re: Secret Service Proposed Postponements (as revised 11/9/95)

Dear Jane:

I am writing to confirm our understanding of the current status of the HSCA records that the Center for Legislative Archives at NARA referred to the Secret Service in 1993.

We understand that the Center for Legislative Archives initially referred to you approximately 500 HSCA records for your review. It is our understanding that the Secret Service is now agreeing to release in full all of these records *except* those that were specifically identified in your letters of November 9, 1995 (refining an earlier list dated October 20, 1995) and your letter of November 15, 1995. These records are listed below. We presume that this is your position based upon our exchanges of telephone calls and letters during the past two months, the photocopies of the documents with proposed redactions that you sent to us on November 13, 1995, as well as points made in your oral briefing to the Review Board.

In your November 9 letter, you identify documents by their HSCA exhibit number.¹ Because the HSCA numbers often identify more than one document, we have attempted to clarify your November 9 list by cross-matching the unique NARA RIF numbers with the HSCA numbers and the hard copies of the documents that you delivered to our offices. (Our notifications in the Federal Register must
