Below is a break down of the articles I read and possible leads for documents as noted in the footnotes of the various articles.

Lee Harvey Oswald in New Orleans: A Reappraisal by Michael L. Kurtz

- P. 8 Kurtz mentions 98,000 pages of documents in the Special Collections Room of Southeastern Louisiana University Library, Hammond, Louisiana that are from FBI, JFK Assassination Files released in December 1977 and January 1978. He specifically references Section 51 No. 105-38341, Report of Special Agent John James O'Flaherty, December 3, 1963.
- P. 10 He also mentions 3,747 pages of Unnumbered Documents on Oswald's Foreign Activities in the Special Collections Room of Southeastern Louisiana University Library, Hammond, Louisiana that are from the CIA files on the assassination of President Kennedy.
- P.11 FBI files, Section 53, No. NO 100-16601. This 85 page report formed The basis for the Warren Commission's version of Oswald's activities in New Orleans.
- P.12 Tapes of interviews with Oswald are in "Interview With Lee Harvey Oswald in New Orleans, August 17, 1963," Truth Records, 1967; and in "Oswald : Self Portrait in Red," 2 record set, Information Council of the Americas, 1964; Stuckey's comments about Oswald are in FBI Files, Section EBF-1153, William K. Stuckey, Untitled description of his conversation with Oswald, 24 November 1963; this FBI file also contains the entire transcript of the Oswald radio interviews.
