On 10/28/63, IC RAYMOND D. BECKER caused a check to be made of the records of the Credit Bureau of Greater NY with negative results.

On 10/29/63, SA AUGUST J. MICEK caused a check to be made of the records of the BCI, NYOPD with negative results.

On 10/25/63, a review of the records of the Identification Division of the FBI failed to further identify subject, GASPER MAIONE.

On 10/23/63, Det. RICHARD CONKLIN, Central Investigations Bureau, NYCPD, 400 Broome St., advised that he was unable to locate any record.

During the course of this investigation in September and October, 1963, telephone calls were made by SA JOHN P. HERLIHY to several families residing in the Brooklyn, NY area with the surname MAIONE with negative results, in an attempt to further identify GASPER MAIONE.
