By letter 8/18/59 the Jacksonville Office advised they had been unable to develop any information concerning the present whereabouts of POPE or FRYE. By airtel 8/18/59 the Houston Office advised that no new pertinent information had been developed concerning the whereabouts of these fugitives. On 8/19/59 Sheriff BILL DECKER advised he had received an anonymous tip that POPE and FRYE were possibly in contact with CECIL BROWN, Dallas pimp, and his prostitute wife, PAT BROWN, who supposedly live in the cabin at Lake Texhoma on the Oklahoma-Texas border. On 8/19/59 DL-91-C advised Bureau Agent that he had recently determined through RUBY JELSEN, FRYE's mother, that sometime in June or July JELSEN had received a telegram from FRYE requesting money. JELSEN went to her employer according to the CI and tried to borrow the money but instead was given \$50 as advanced bonus money which she would have received in August, 1959.

On 8/19/59 JELSEN's employer, Mr. JOHN NEWBERRY, Executive Vice-President, Clockwise Fashions, Dallas, advised that he recalled that in the middle of June, 1959, RUBY JELSEN had made a request for funds and was given a \$50 bonus in addition to her regular weekly pay of approximately \$45. On 8/20/59 NEWBERRY advised he had ascertained that JELSEN had sent a \$50 money order on 6/19/59 to her daughter, FRYE, using the alias of JOYCE THOMPSON (FRYE). The money order was sent to Marshall, Texas. Dallas is conducting immediate investigation at Marshall in an effort to determine whereabouts of subject and/or FRYE.

SUBJECT IS HEAVILY ARMED AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS. FRYE IS ALLEGEDLY ARMED WITH A .32 CALIBER AUTOMATIC, HAS ASSAULTED POLICE OFFICERS IN THE PAST AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS.
