Prior to her departure from New York, June Cobb visited the Cuban Consulate in New York City as requested prior to her departure from gavana. While there she was introduced to an American citizen named Bernie Brenner, a newspaperman from the Mismi Reach Run. Brenner is a friend of Cobb's boss Juan Orta, the Administrative assistant of Fitel Castro. Brenner gave Cobb a note in an envelope that was sealed for delivery to Orta. Cobb opened the note and copied the contents which were as follows:

"Tell "0" that Harmy (Manuel) argues (simi) is "not, real not". The Peds are on him. Against the priest fin ered him in Ashinston". "Menender in Esy west works in the postoffice is being watched. There is a fed working right there in the post office with him. They have some letters marked just waither for him to ober "one. Has not. The State Department - Also tell'em not to use those replicas of dollar bills the tourist pointment is using with something written on back".

"George Southworth is working with the feis. I got he drunk with a "les" (lesbian) and a straight with some sicturer one night. He said he was going to put the shift to Capt. Ouerra."
"Tell Doris dedrone who lives in 8 y 19 pt. building with a paby by Orlando radrone that the feds are trying to get to her. Bidel brought her to Cuba because she knew some things she shouldn't know".

"Arques can go to Cuba the 13th".

"Oscar Famirez is being tailed, 24 our tail".

June Cobb called Igor Cordevitch, Director of "Vision" in New York through whom I originally met Miss Cobb, asking him to contact me for she had a message for me. Correvitch called me at none and I called Miss Cobb at a phone booth in the total Drake. Spe told me of the above. I had her give the notes to maximistic Miss Cordevitch. She passed them to him at the Fast Side firlines Terminal in New York on the evening of ? June.

Burch: According to information given verbally by Harry Hermsdorf, when Igor went to the airport and approached Cobb, she waved him away. He waited at some distance while she scritbled away at the notes; she then folded them in a newspaper and left them for him to pick up. Harry did not say whether she walked away immediately after leaving the notes, or whether she folded them in the paper and then waited for the two supposed members of the Cuban Consulate to join her before boarding the plane.
