SUBJECT

1. AT 1655 ON 7 MAY 1574 WE RECEIVED A TELEPHONE CALL ON THE LISTED LINE FROM FRANK STURGIS, WHO INDICATED THAT HE WASTED TO MIET WITH US AU SOON AS POSSISEE IN CROEK THAT HE MIGHT CONVEY INFORMATION OF EXTREME IMPORTANCE TO THE AGENCY. HE MENTIONED AT THE OUTSEL THAT HE HAD ARRANGED TO MEET WITH FIELD CFFICE AT AN EARLIER DATE.

BUT HAD FAILED TO APPEAR AT THE APPCIATED TIME AND PLACE. WE DID NOT COMMET ON THE APPCIATIVE MACVAME MESTING; HOWEVER, WE IMMEDIATELY ADVISED STURGES THAT WE ARE NOT IN A POSITION TO MEET WITH HIM. WE SUGGESTED THAT IF HE REQUIRED ASSECY CONTACT HE SHOULD DO IT AT THE WASHINGTON LEVEL. HE ASKED WHO IN WASHINGTON HE MIGHT CALL. WE INDICATED THAT WE WERE URABLE TO SUGGEST A SPECIFIC HAME.

2. STURGIS THEN SAID THAT HE DIDN'T WATT TO PLAY GAMES AND HAI HE WAS PREPARED TO GIVE US HIS INFORMATION OVER THE TELEPHONE.

HE IMMEDIATELY SAID THAT IT CONCERNED MARCOTICS IN MEXICO AND THAT A HUMBER OF VERY HIGH RANKING PEOPLE WERE INVOLVED. WE TOLD HIM THAT IT WAS UNNECESSARY TO GO ANY FURTHER BECAUSE THIS WAS A PROBLEM FOR THE DRUG EMFORCEMENT ASSUCY, AND SUGGESTED THAT HE CONTACT THEM. HE RESPONDED THAT HE HAS HAD CERTAIN PROBLEMS WITH DEA, BUT HE INDICATED THAT HE MIGHT CALL SECRGE DAVIS, FBI, HIAMI, WHOM HE HAS KNOWN FOR SOME TIME. WE AGREED THAT THIS MIGHT BE AN EXCELLENT IDEA. STURGES THAN THANKED US AND THE CONVERSATION WAS TERMINATED.

3. STURGIS WAS VERY PERSONAFLE, BUT FRANK, DINITY THIS BRIEF CONVERSATION. WE BELIEVE THAT HE UNDERSTANDS OUR POSITION, AND WE DO NOT ANTICIPATE THAT HE WILL ATTEMPT TO CONTACT US AGAIN. ...
