PART THREE OF THEEE

- 1. This portion of my report on above meeting deals with miscallaneous information which came up during that meeting and throws, perhaps, some additional light on the MRF's political posture.
- 2. Throughout the entire conversation it became quite clear that Marriel Ray and his advisors must have dismissed amongst themselves the various probing questions which Berder had recred with individual MRPers on various occusions; as a result of these tasks amongst thomselves it appears to me trat the NEF is beginning to tome down some of its more controvental qualitions: there was repeated reference to the MRF's desire and conviction to remain on the best of terms with the U.S. and to be fully deemdated to the free West, most emphasized Bay rejected any implication that he ami/or his group might have "heritralist" assirations -he dies not see himself in the role of a Latin American Masser. Again and again, Manual Ray emphasized the mood to fight the Soriet Union's influence in Cuta to the utmost. When asked in this connection whether he would retain the Suviet/Chica embassies in Gubay he first tried to talk around the subject, saying that these relationships would have to be considered in the light of existing circumstances at any given time; he closed this topic by saying that these issues of international significance had not been fully considered as yet by himself or his staff and that they would be given full thought in the forthooding weeks.
- 3. When asked to define his position vie a vis the Church, Ray pointed with prine to Valdes Pino and heinol Gonzalez the former an important lay Church leader, the latter an important figure in Cuba's Catholic labor element. According to Ray, some night-ranking prelates are also closely affiliated with the MRP. In other words, Ray claims that he is working wall with the Church and the Church is working wall with his novement. He, Ray, asked whether I had received the final copy of the MRP's program, which he said was quite different from the first draft that had been given to me. (Comments this program was recently published in Arabor and is more than platform has been toned down a bit.)
- And has informed no that the Ouben Executive Countities of Rasopia HDO group has broken with Rasop and is now working closely with the KRP.

- 5. Ray inquired whether or not a decision had been made on the training of certain MRP singletons. I said that this was a matter for discussion on the technical livel. (Comment: unless this has been done already, I would suggest that MR/4/FM transmit partinent instructions on this matter to MISH as soon as possible.)
- 6. Do we have explosives inside Cube now which could be given to the MRP people at an early date, Ray asked? My answer to this was that I simply did not know. (Comment: I would suggest that Will/PM examine this matter and furnish partiament instructions—whatever they may be to MASH.)
- 7. While Ray never deviated during this meeting from his previous agreement to coordinate military plans with us, he continued to probe to find out whether or not we would be milling to simply furnish his the means with which this group could unilaterally mount operations. A case in point: "We need a boat," hay said. It is realized that such a boat costs money and, later on, certain cover arrangements will have to be devised. Could we buy the boat; could we provide it with the necessary cover; and, after this is done, would we then turn the boat over to the MEP to be used as they see fit? My answer was that this would fall into the estegory of duplication, which had been explored fully previously during this meeting. (See parts one and two of this Contact Report.)
- 8. Ray informed me that he had sent word to Tony Varona and that a meeting with him would be arranged scon; we all must participate in establishing a system under which democratic institutions can be established and can be preserved, Bay remarked.
- 9. Ray told no that he and Chibas had an appointment with a Mr. Sex Halparn(7) of Time magazine in the efferment of 22 November.
- 10. Could I expedite a visa for Emilio Gueddes, a Cuben currently working in Medrid for Guastelle, a Cuben firm? Winddes is to be utilised by the HRP in psychological warfare work. I said that I would look into this metter.
- Il. About three times during the meeting, Ray made a request for special maps which, he said, were prepared by the Asrial Service Company in Philadelphis, Permsylvania. This company was not sailing these maps publicly. Could I use my influence with the Pertagon or other places to get these maps? Ray also stated that this problem had been raised previously in Miani with [Jim Smith.] (Gomment: unless there are some strong objections, I would feel that these maps could be made available to the MRP through our military channel. It is suggested that Will/PM carry the ball on this, be it pro or con.)
- 12. Ray volunteered the information that Sori Marin has about 100 men under his command in Oriente Province. Ray felt that Sori had big influence in the Sterra Maestra and that his, Sori's Johnstones vere with the MTP However, after the Sinesic waish Escantian detacle, Sori's Do enturisism had cooled somewhat and perhaps this would not be the time to make any approaches to Sori 104 lowest I seem to recall some mevicus MISM traffic on Sori Dotherafore, this item is called to Michigans attention for whatever use they intend to sake of it.

13. Approximately five MRP people currently stationed in New York are in touch with Fidelistas in that area, Ray said. The MRP people are obtaining intelligence from these Castro followers and at the same time working on them to induce their defection. Ray did not want to give the names of there people to me and I did not pursue the matter further at this session.
