SUBJECT: Meeting with Marriel Pay and Smil String in the latter's apartment (30 West nOth Street, New York City) on 22 November, 1960.

- 1. This posts m of my report on above meeting deals with miscellaneous information which name up furnish to a meeting and throws, permaps, some sound one high term it w MRS is positively posture.
- 2. Throughout the entire conversation at became quite clear that Marriel Ray and his admisers must have discussed amongst themselves the various probing questions which Eender had raised with individual RRPers on various occasions; as a result of these takes amongst themselves it agreers to us that the MRP is beginning to tome down some of its more controversial positions: there was repeated reference to the MRP's desire and constition to remain on the best of terms with the U.S. and to be fully commutted to the free West; most emphatically, Ray rejected any implication that he and/or his group might have "neutralist" appirations -- he does not see himself in the role of a Latin American Nasser. Again and again Manuel Ray emphasised the need to fight the Soviet Union's influence in Cuba to the utmost. When asked in this connection whether he would retain the Soviet/ChiCon scrassies@in.Cola, he first tried to talk around the subject, saying that these relationships would have to be considered in the light of existing circumstances at any given times he closed this topic by saying that these is wes of international significance had not been fully considered as yet by himself or his staff and that they would be given full thought in the forthorning weeks.

When asked to define his position vis a vin the Church, Ray pointed with price to Valdes Pino and Reinel Jensiles—the former an important lay Church leader, the latter an increase flight in Cubals Catholic labor element. - 5. Bay inquired wisther or not a decision had been made on the training of certain MRP singletons. I said that this was a matter for discussion on the technical level. (Comment: unless this has been done already, I would suggest that WH/h/H transmit partinent instructions on this matter to NASH as soon as possible.)
- 6. Do we have explosives inside Cuba now which could be given to the MRP people at an early date, hay asked? By answer to this was that I simply did not know. (Comment: I would suggest that MRI/L/PM exemine this matter and furnish pertinent instructions—whatever they may be to MASH.)
- 7. While Ray never deviated during this meeting from his previous agreement to coordinate military plans with us, he continued to probe to find out whether or not we would be willing to simply furnish him the meets with which this group could unilaterally mount operations. A case in point: "We need a boat," Bay said. It is realized that such a beat costs money and, later on, certain cover arrangements will have to be devised. Could we buy the boat; could we provide it with the necessary cover; and, after this is done, would we then turn the boat over to the MEP to be used as they see fit? My snaver was that this would fall into the category of duplication, which had been explored fully previously during this meeting. (See parts one and two of this Contact Report.)
- 8. Pay informed me that he had sent word to Tony Yarona and that a meeting with him would be arranged soon; we all must participate in establishing a system under which democratic institutions can be established and can be preserved, Ray remarked.
- 9. Ray told me that he and Chibas had an appointment with a Rr. Sam Halpern(?) of Time magazine in the afternoon of 22 Movember.
- 10. Could I expedite a visa for Emilio Gueddes, a Cuben currently working in Madrid for Guastella, a Cuben firm? Gueddes is to be utilised by the MRP in psychological warfare work. I said that I would look into this matter.
- 11. About three times during the meeting, Ray made a request for special maps which, he said, were prepared by the Aerial Service Company in Philadelphia, Permeylvania. This company was not selling these maps publicly. Could I use my influence with the Pentagon or other places to get these maps? Ray also stated that this problem had been raised previously in Mismi with Jim Smith. (Comment: unless there are some strong objections, I would feel that these maps could be made available to the MEP through our military channel. It is suggested that Will/PM carry the ball on this, be it pro or con.)
- 12. Ray volunteered the information that Sori Marin has about 100 men under his command in Oriente Province. Ray felt that Sori had big influence in the Sierra Masstra and that his, Sori's, sympathies were with the MRP. However, after the Sinesio Walah Escambray debacle, Sori's enthusiass had cooled somewhat and perhaps this would not be the time to make any approaches to Sori. (Comment: I seem to recall some previous MASH traffic on Sori; therefore, this item is called to WM/W/RN's attention for whatever use they intend to make of it.)

13. Approximately five MEP people currently stationed in New York are in touch with Pidelistas in that area, Ray said. The MEP people are obtaining intelligence from these Castro followers and at the same time working on them to induce their defection. Ray did not must to give the names of these people to me and I did not pursue the matter further at this session.
