### NEMCRANDUM FOR THE RECORD

SUBJECT: Transcript of Recorded Summary of ANPAIN Heetings

1. This memorandum summarizes discussions which have taken place from 27 March through 30 March between Mr. Schoards, Mr. Foster, Nr. Rivers, Mr. Thompson and Mr. Falmer. During this period, we have discussed a number of topics under the following headings: General; Political; Propaganda; Action and Immediate Plans.

## General.

2. It is agreed, first, that any possibility of reaching a peaceful agreement on the problem confronting us in Cuba is no longer present and that Fidel has passed the point of no return. Second, prompt action is desirable because the situation is growing worse every day, and the solution to the problem becomes more difficult as it is allowed to deteriorate. Third, this problem is not limited to Guba alone but is international in scope.

## **Political**

3. It has been agreed first that a name, a platform and a symbol should be chosen at the earliest opportunity. It has also been agreed that these gentlemen will meet in Jacksonville on the 3rd and 4th of April with representatives of other groups who have similar opinions of the situation and who wish to coordinate their actions. It will be at the Jacksonville meeting, and if necessary at later meetings in Havens, that decisions will be taken on the name, platform and symbol for the joint organisation, which we will meanwhile refer to as the Junta.

It is agreed that the spirit of the Caracas Pact should be revived wherever ressible in the official prenouncements of the Junta. Kr. Edwards, Kr. Poster and Mr. Rivers are preparing their own platform of political, social and economic measures which they will take with them to the meeting and witch they will provide to us. At the forthcoming meeting, names of recople to be crealy identified as representatives of the Junta will be decided. At the Jacksonville meeting these gentlemen will tear in mind the idea that they wish to make it cossible for others who

cannot attend the meeting to express their adherence to the principles expressed there at a later date. Therefore, they will not attempt to impose a single narrow system of political, economic or sociel thought, but rather will emphasise the need for a return to constitutional government under which all parties have the right to express their own opinions and the people have a democratic choice.

# Propaganda.

- 5. We plan to employ press, radio, films, intrusion and other techniques to undermite and discredit the government and to prepare the people for later action. This phase will have as one of its objectives the dissemination of the truth to people who have been misled by the present regime. The names of specialists in radio work have been provided, and the decision will be made later as to which of these will be used in which place. Three men who have been selected for this radio work are Juan PALLI, Antonio ALCASO Avila, Higuel SURREZ Fernandes and Angel Felix YERGO. Other names are on a list which has been provided.
- 6. Discussion was held concerning the technique of having some material prepared in Havana and sent outside for broadcasts back into the country. It was felt that this technique, would permit timely exploitation of developments inside the country. Another suggestion involves staging incidents which would arouse Castro, filming his impassioned reaction on TV or in public appearances and then, by careful editing, to emphasizing gestures and facial expressions to produce a good satirical film. This film might also employ a musical background carefully sychronized with Castro's movements as a way of heaping on additional ridicule.
- 7. We also discussed ways of printing material outside of Cuba for later distribution inside the country or in other target areas. One specific example was a pemphlet on the denial of human rights in Cuba today, which it is hoped can be prepared in time for distribution at the forthcoming conference on Freedom and Democracy in Caracas. Another technique in connection with radio broadcasts involves the use of small pocket recorders. These would be carried on the versons of representatives of the group for surreptitious recordings of casual conversations which, after editing, could be replayed over the air to give whatever impression which we wish to create. Still another technique involves the use of indestructible recorderspeaker equipment which can be left in pu lie places with pre-recorded messages. Another uses tape recorders and loud speakers placed in hotels overlooking public assembly areas where, after an appropriate period of blank tape, a message can be broadcast, to sow confusion and consternation among the authorities. Another propaganda technique which might be employed would be wall resters with pictures of Fidel tearing the beard made of some substance which dissolves readily in the rain and which would leave a rather ridiculous-looking, beardless figure following a rain.

## Action

8. After a lengthy discussion of this question, it was decided that precise means of action should be determined following meetings with other leaders and

meetings with experts in this field. It was also agreed that, meanwhile, training of qualified people should proceed. In this connection, it was agreed that an assessment program based in the Kiami area would be the first step. For this a team of three or four people headed by Manuel Artime has been designated. It is expected that on the 31st of March these gentlemen will meet with him in New York and will explain to him his duties which will be the following:

- a. He will be instructed to make contact with certain selected people who are already in this country. He will base his contacts on clearances which are received through a representative of Hr. Frank Bender, who attended several of the meetings.
- b. After Artime has made his initial assessment of these candidates and has obtained their agreement to participate, he will send other, less well-known members of the team to escort these people into the assessment areas where they will undergo medical, intelligence and psychiatric examination. A list of 16 candidates who are ready at the moment and most of whom are already available in this country has been submitted. It is expected that an additional number, bringing the total to somewhere between 30 and 100 can be located following the return of these gentlemen to their homes. It has also been agreed that a list of 20 members of the old army who are now in the Miami area, will be carefully screened and checked by these gentlemen on their return and that those on whom no derogatory information is available will be the subjects of Artime's pressessment.
- 9. The initial cadre of instructors will emerge from the group of 20 and the group of 16. Those who are chosen later will be instructed in turn by the initial cadre at a location to be chosen outside of this country. The question of specialists was also taken up. In the field of physicians, including as chiatrists, there are a probable ten or more who can be recruited and brought out at such time as the need for them arises. There are eight or more specialists in small boat operations who would be of value in exfiltration operations. There are approximately five qualified pilots. There are vife or more radio communicators. This will be the subject of a later comment. The group also has access to several boats capable of travelling out as far as the territorial limits of three or twelve miles, and probably even further. There are four or more such boats available. In this connection the question of radio beacons and their use in exfiltration operations was also discussed. It was pointed out that equipment may soon be available which can be carried by small eraft and which will make a rendezvous at sea more simple and more secure.

# Ismediate Plans

10. A schedule was drawn up to show the movements of Mr. Edwards, Mr. Rivers and Mr. Foster during the week or so. Following are the activities which each expoet:

- On 31 March, Mr. Foster will go to New York where he will meet with the o there and Kahuel Artime who's expected to return from Hexica on the same date. The meeting will be held at the Statler Hotel. On the first and second of Arril, Mr. Poster will be in New York. On the third, he will proceed to Jacksonville, on the fourth he will meet there with representatives of other groups. On the fifth, he will return to Oblavana and there he will talk to Hermano LAZA concerning the possibility of that Hermano LAZA can come to this country for approximately four weeks of specialized training in communications. It is contemplated that if 66 (Hermano LAZA) is available for this, then he on his return to Havana will be in a position to pass his training along to a group of other people. This would be extremely important in the event that relations were to be broken. Another assignment of Mr. Foster will be to carry with him to certain reople in Havana the decisions reached at the Jacksonville meeting. This is assuming that certain members whose presence is desired will be unable to attend the Jacksonville meetings and will therefore have to be contacted by Mr. Foster on his return. Another task which has been given him is to check out the list of twenty names of candidates in the Miami area which came from another source.
- b. Mr. Rivers will accompany the other members of the roup to New York on the 31st. He will go with them to Jacksonville on the third, he will go to Tampa and Miami on the 5th and 7th and will probably return to Havana on the eighth.
- c. Mr. Edwards will go to New York on the 31st with the other two. He will meet there with Artime on the 31st and on the first. On the second, he will go to Boston to speak with Mr. Rodriquez Bezog concerning possible 06 training of the latter in communications work. Mr. Charles Barker will meet him there and will speak directly to Mr. Rodriguez Bezog if the 06 possibility looks good. Mr. Edwards will proceed then to Jacksonville on the third for talks there and will return to Havana at some later date.
- d. Concerning Mr. Artime, his instructions will be to return to Miami after the New York meetings and await contact from a representative of Mr. Carl Bender. He will be instructed in more detail there on how to proceed with the reception and assessment of people chosen for the action phase. These detailed instructions will come from the representative of Mr. Bender. Before he leaves New York or in the early afternoon of the 31st of March, Mr. Artime will also make contact with Mr. Alberto Roque at the Commodore Hotel to discuss collaboration of Roque with the group. Mr. Artime has been chosen for this work since he will not be returning to Havana and the question of exposure is not critical here.
