On 6 October 1969, Source BER-10 provided information regarding correspondence to SUBJECT, a summary of which is as follows:

A personal letter, dated 30 September 1969, addressed to SUBJECT from Sergeant Arthur Lee Jr., 425-94-4603, Student Company B, USIMA, Mata Company Grade Class 4-70, Box 6745, Fort Bragg, North Carolina, 28307, a Negro associate of SUBJECT, indicates that Lee is presently undergoing training at Fort Bragg. Lee mentioned that he left Germany to go to Vietnam but that he is, at the moment, unsure that this assignment will occurr. Lee stated that a determination as to whether he goes to Vietnam should be reached in January of 1970. If Lee does go to Vietnam, he will send for SUBJECT in the early part of 1970.

AGENT'S NOTES: Attention is invited to Agent Report by the undersigned, dated 10 September 1969, Subject as above, wherein Lee's intention to marry SUBJECT is reported. Lee is apparently the father of SUBJECT'S expected child.
