Long Beach California
March 30, 1964

"Dear Mr. NORTH:

"Attended a public meeting at the Embassy Auditorium, Embassy Hotel, in Los Angeles at which attorney MARK LANE was the main speaker. Meeting held under the auspices of the 'Citizens Committee of Inquiry.'

"Tickets were sold (\$1.50) in front lobby of auditorium. The enclosed piece of literature was given to me on sidewalk at entrance of auditorium (literature by ALLEN NOONAN). MR. NOONAN was connected with the Long Beach Peace Information Center and am aware of some of his local activities.
