On 12-3-63, this informant advised that he is not acquainted with anyone named EDDIE MARK nor does he know anyone believed by him to be identical with such an individual.

On 12-4-63, this informant advised that on the night of 12-3-63, he was talking to JACK BUHLINGLER, address unknown, but who is employed as a cab driver by St. Louis County Cab Co. BUHLINGLER remarked to him that JACK RUBY, the man who shot LEE OSWALD in Dallas, Texas, was a cab driver employed by Ace Cab Company at St. Louis "years ago". CI said that BUHLINGLER indicated to him he had been furnished this information by one or more "old time cab drivers" who used to work for Ace Cab Co., or by veteran cab drivers still at Ace Cab Co. CI is aware that several drivers who worked for Ace 10-to 15 years are now employed by St. Louis County Cab Company, although he was unable to furnish their names.

He had no further information to furnish concerning this matter, and requested that his identity as the recipient of this information from BUHLINGLER be concealed since he does not know whether BUHLINGLER may have furnished the information to any other person or persons.
