On thexax Nov. 22, 1963 the following sources were contacted regarding the assassination of the President and were requested to telephone SA Ralph D. Scott should they receive any information related, even remotely or indirectly, to the assassination:

> Garland Thomas, COP, El Dorado, Ark.; LR 521-C; LR 561-C; Mrs. Genevieve Hood, PCI, El Dorado, Ark.; Edward Ira Craig, PCI, El Dorado, Ark.; Ex G. B. Cole, COP, Camden, Ark.

On 11/26/63 all of the above were recontacted and all advised they have not received any information, except through public sources, regarding the assassination of the President nor do they personally know anxing the persons whose names have been connected with the assassination.

On 11/22/63 SA Ralph D. Scott personally observed Tommy Sam Kilcrease at the Camden (Ark.) News, Camden, Ark., where he is employed. Kenneth Poindexter, also an employee at the Camden News, said he had lunch whith Kilcrease and had been with him constantly between 12:00 noon and the time he was observed by SA Scott at 4:00 pm.

On 11/25/63 Freed Phillip Greeley, Wire Rd., Camden, Ark., Texx Tel. TE 6-5298, telephoned Channel 7, LR and referred to a Newscast by former employee Gene Goss and indicated consern about some statement by Goss in a news report on some prior date. He said he had been bothered about this statement for some months and he now fears there may be some connection between it and the death
