regard to Cuba. This report further reflected that BUCHAMAN, in addition to being a newspaper writer, was getting involved personally in revolutionary activities pertaining to maiti and Cuba.

Miami file 47-4019, Bufile 47-48702, pertains to a fugitive investigation on JERRY BUCHANAN, FBI #148937D, the brother of JAMES BUCHANAN. That case involved the use of U.S. Army identification in the name JESSE L. MURPHY by JERRY BUCHANAN in cashing three stolen checks at Miami. That file reflects the brother of JERRY BUCHANAN as JAMES CHARLES BUCHANAN, and the parents as JAMES and MARY BUCHANAN, 3543 Northwest 33rd Street, Miami.

Miami file 2-317, Bufile 2-1712, also pertains to JERRY BUCHAMAN, FBI #148937D, and this case was based on recruiting activities by JERRY BUCHAMAN for the Anti-Communist International Brigade of FRANK FIORINI. The same file reflects JERRY BUCHAMAN was sent to the Florida State Penitentiary as of 7/28/61 for three years as a Parole Violator from a forgery conviction.
