"A conversation between JAMES GRIESI, EARL KEIHL and MAX WEINSTOCK, all representatives of the United Furniture Workers in one form or another, took place today in the Baltimore office, 27 E. North Avenue, on the death of President Kennedy.

"All took the popular position advanced by the public, in that the assassination of the President was a cowardly and dispicable act. However, JAMES GRIESI, after describing how he learned about the President's death, took the position that this was a National plot against Kennedy. GRIESI told MAX, EARL and SYLVIA PRESS, the office girl who was present at the time, that he broke down completely upon hearing of the assassination and realized that the country not only lost a young and aggressive
