Re Miami report of SA LEMAN L. STAFFORD, dated 1/22/60.

On 2/23/60 [WF 1161-S] and on 2/29/60 [WF 1205-PSI] advised SA DONALD HOETING that his only knowledge of the captioned newspaper is that it is a Cuban-language weekly published in Miami and which is anti-CASTRO in nature.

On 2/25/60 CARLOS MARQUEZ STERLING, who has furnished reliable information in the past, and who requested his identity be protected, advised SA HOETING that "Cuba Libre" is a Spanish-language newspaper printed weekly in Miami and which is opposed to the present government of FIDEL CASTRO. [STERLING] stated that the weekly is not distributed in the Washington, D. C., area but that he does receive a copy each week through the mail. STERLING stated he is not aware of the identity of the owner of the newspaper but stated that the return address on the mailing wrapper of the newspaper that he receives is Post Office Box 2235, Miami, Florida. [STERLING] could furnish no further information concerning this newspaper.

3. Will attempt to determine disposition of the 8,000 copies of "Cuba Libre" presently in possession of Colonial Press and anticipated disposition of the additional 8,000 copies presently on order.

4. Will maintain contact with Miami informants relative to activities of captioned organization.

It should be noted that Miami has designated four copies of this report to the case file. Additional copies are being made should it be necessary to send these copies to other field divisions should investigation be required in those areas.

The FD 302 reflecting interview of VINCENT D'AMATO reflects dual file numbers 97-309 and 105-2130, and will be found not only in this report but also in the report involving JOSE ACOSTA PEROVANIS, inasmuch as it contains pertinent information regarding "Cuba Libre" as well as activities of ACOSTA who has been associated with that publication.
