Copies of this letterhead memorandum are being furnished to Office of the Coordinator of Cuban Affairs, ONI, Border Patrol, U. S. Customs, U. S. Coast Guard, CIA, OSI, G-2 and OSI.

New York is requested to make a copy of this letterhead memorandum available to U. S. Customs, New York City.

This letterhead memorandum is being classified Confidential inasmuch as it contains information extracted from a CIA communication which was so classified.

For the information of Savannah, relet reflects that a check was to be made concerning identity of registrant for 1963 Fla. License 1D-49526. A check of the Dade Co. Auto Tag Agency reflects that license was issued for a 1961 Falcon to HERIBERTO M. SANCHEZ, 225 S. W. 15th Road, Miami, Florida. No identifiable information in Miami indices concerning this individual and only possibility reflects no derogatory information. It does not appear that the identity of this person is of any significance at this time in view of the fact that invasion of Cuba, as alleged and reported by the Savannah Office, involving members of the AM has not taken place. It is believed that no further investigation should be conducted concerning this particular activity.

Miami will continue to follow the activities of the AM through its sources, particularly through MM 873-S. (L) Miami will contact CIA for any information reflecting operational interest in this organization in view of information furnished by MM 873-S that the anti-CASTRO organization, UR, has approached the AM and offered them aid in an infiltration program in Cuba.

The identities of the Tampa sources who had no information to indicate activity on the part of this organization in that area have been set forth in Tampa letter to Miami dated 5/29/63.

Investigation concerning the arms transaction involving the FORDC as set forth on page 1 of letterhead, memorandum is being reported under caption of the FORDC.
