Re San Juan airtel, 9/30/69.

On 10/17/69, ENRIQUE GONZALEZ GIRIBET, former PSI of the SJO, advised that when he went to Ponce on 10/13/69, the El Capri Bar was closed and thus he did not have an opportunity to further identify the owner. He described owner as being about 35 years of age, 5'9" and 175 pounds. (X)(U)

On 11/21/69, GONZALEZ was recontacted and advised that he has not been to Ponce in the past month and could furnish no additional information. He will attempt to obtain further information when his business trips take him to Ponce. (X)(U)

GONZALEZ volunteered that he will be in the Ponce area on 10/6/69 and will return to San Juan, Puerto Rico on 10/9/69. He volunteered that he would furnish further information to the San Juan Office on or about 10/9/69, after he recontacts the owner of the El Capri Bar in Ponce. (u)

This LHM is being classified CONFIDENTIAL in view of the information furnished by SJ T-1, the unauthorized disclosure of which could prove inimical to the defense of the United States.

On 9/29/67 the Office of Intelligence, Police of Puerto Rico, was advised by SA SINECIO GUTIERREZ of the contents of the LHM.

On September 29, 1969, SJ T-1, a source contacted an insufficient number of times to determine reliability, advised that he is a traveling salesman in Puerto Rico and travels to Ponce, Puerto Rico at least once a month. (S U)

SJ T-1 is an admitted member of the ELC.

The ELC is an anti-Castro group with headquarters in Miami, Florida. The leader of this group is HIGINIO "NINO" DIAZ ARE.

On September 29, 1969, SJ T-1 advised that he was in Ponce, Puerto Rico last week and he casually met the owner of the El Capri Bar, Carretera Penuelas, Ponce, Puerto Rico; however, he does not remember his name. (S U)
