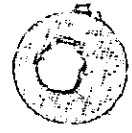

Re Dallas letter to Bureau dated 5/29/67 and notation from Bureau dated 6/7/67 approving interview with subject.

There are enclosed for the Bureau 9 copies of a letterhead memorandum setting forth an entire summary of information concerning subject, including results of interview with him at Dallas on 7/25/67. Two copies of this letterhead memorandum have been forwarded to U.S. INS, Dallas.

The Bureau, New York, Miami, and WFO have advised that indices searches were negative concerning subject. WFO advised that check on 4/28/67, with Security Office, CIA, was negative and check on 4/24/67, with Biographic Register, CIA, was negative. Checks were made by SA ROBERT F. ROBINSON, JR.

Miami by letter dated 5/10/67, advised logical sources were negative concerning subject.

New York has advised that logical sources at New York are negative concerning subject.

The sources contacted at Dallas, Texas, with regard to subject were DL 308-PSI and DL 282-S contacted on 5/16 and 17/67 respectively, by SA WALLACE R. HEITMAN.

The credit and criminal checks performed at Dallas were by IC JOE A. PEARCE.
