Referenced communication points out that the Agrupacion Montecristi (AM) has moved its headquarters to San Juan, Puerto Rico, therefore, the San Juan Office is being designated the Office of Origin in this matter.

[MM 873-S] has pointed out he anticipates little or no activity on the part of the AM in Miami, Florida, in the near future. Miami is therefore, closing its file concerning captioned organization. Miami will maintain contact with [MM 873-S] who is in a position to furnish pertinent activities concerning the AM and will advise the Bureau and the San Juan Office of any pertinent information developed.
