SP 1159-S on 9/15/59 advised that at a meeting of MARGARETE FITZMAN's CP Club on 9/14/59, after she and her family had departed, it was announced that she was on her vacation and would return the next week. A neighborhood source advised that Mrs. FITZMAN was heard to comment that she and her family would be in Europe for approximately one year but that there was no mention of the employment of JOHN FITZMAN.
