Re Milwaukee letter to the Director dated November 14, 1956 and Bureau letter to Milwaukee dated November 27, 1956.

WALTER SCHWULST, a PCI of the Milwaukee Office, advised on November 26, 1956 that a professional strip-teaser, whose professional name is CANDY BARR, is the girl who appears in an obscene film entitled "Smart Alec." He stated that a picture of this girl appears on the cover of the November, 1956 issue of "Jem" magazine and that her picture again appears on page 15 of the same magazine. He further advised that her picture appears in the Fall, 1956 issue of "Escapade's Choicest" on pages 42 and 43. The PCI stated that this girl was supposedly employed by the Colonial Club somewhere in Texas and believed it was either in Dallas or Galveston. He advised that he had also heard that she is the one who shot her husband when he attempted to break into her apartment after she had secured an injunction in order to keep him from bothering her. He advised that he does not know her true name or present whereabouts.



Enclosed for the FBI Laboratory are the two magazines in which the pictures of CANDY BARR appear. The Laboratory is requested to compare the photographs of CANDY BARR in the magazine with the girl who appears in the obscene film, "Smart Alec." This film was sent to the Laboratory on November 14, 1956 under the caption of "RURIK KELNER ANDERSON" and appears as Q5 in referenced Bureau letter to Milwaukee dated November 27, 1956.

If the Laboratory feels that CANDY BARR is the girl who appears in the obscene film, "Smart Alec," they are requested to make some photos and submit them to
