Transmitted herewith for the Bureau are 9 copies of a letterhead memorandum captioned "CUBAN REVOLUTIONARY ACTIVITIES" and dated September 22, 1960. One copy of this letterhead memorandum is being furnished to the New York Office for information in view of the comments made therein regarding NADJA BUCKLEY, who allegedly resides in New York City and one copy of this letterhead memorandum is being furnished to the Miami Office for information in view of the interest of that office in matters that possibly bear a relationship to Cuban revolutionary activities.

The data set forth in the enclosed memorandum was furnished by NO-T1, confidential informant BETTY PARENT, to SA REGIS L. KENNEDY on 8/31/60 and additionally to SA WARREN C. DE BRUEYS on 9/21/60. Confidential Informant NO-T2 is FELIX LORINO, Manager, Municipal Yacht Harbor, New Orleans.

One copy of this letterhead memorandum is being furnished by the New Orleans Division to the local office of the U. S. Customs Agents for information.

The above is being furnished to the Bureau solely for general intelligence information purposes and no investigation is contemplated by the New Orleans Office in this matter.
