Re Butte letter dated 4/10/72.

On 6/26/72, ARTHUR HODGENS, advised that in recent contact with BS 1891-PSI it was determined that CAROLYN MUGAR has not permanently returned to Boston. According to BS 1891-PSI, MUGAR did visit with friends in Cambridge during April of 1972, returned to Boise in early May and again returned to Boston on 5/19/72.

She returned again to Boise on 6/8/72. On 6/15, 17, 18/72 she was at Sun Valley and left a telephone where she could be contacted which was listed to the campaign headquarters of Sen. GEORGE MC GOVERN.

Source also commented to HODGENS that CAROLYN traveled to Washington D.C. on 5/22/72 to take some pictures. She spent one day in Washington D.C.

Source advised that CAROLYN is continuing to operate a GI coffee house near Mountain Home, Idaho.
