regard to Cuba. This report further reflected that BUCHANAN, in addition to being a newspaper writer, was getting involved personally in revolutionary activities pertaining to Haiti and Cuba.

Miami file 47-4019, Bufile 47-48702, pertains to a fugitive investigation on JERRY BUCHANAN, FBI #148937D, the brother of JAMES BUCHANAN. That case involved the use of U.S. Army identification in the name JESSE L. MURPHY by JERRY BUCHANAN in cashing three stolen checks at Miami. That file reflects the brother of JERRY BUCHANAN as JAMES CHARLES BUCHANAN, and the parents as JAMES and MARY BUCHANAN, 3543 Northwest 33rd Street, Miami.

Miami file 2-317, Bufile 2-1712, also pertains to JERRY BUCHANAN, FBI #148937D, and this case was based a on recruiting activities by JERRY BUCHANAN for the Anti-Communist International Brigade of FRANK FIORINI.
