On July 29, 1960, PSI MARIANO FAGET DIAZ, former

the past, informed SA STAFFORD that subject currently operates
a garage and service station on SW 8th Street, Miami, Florida,
the exact address unknown to him. PSI said subject has
telephone number FRanklin 4-9292 (u) *CS*.

He described subject as being a member of the
growing colony of anti-CASTRO Cubans, but said he did not
know of any activity on the part of subject which would place him
in violation of any United States laws.
