the Miami Office. He is a white Haitian, who is currently
in the U. S. on a Visitor's Visa. He was one of the
owners of the Nacional Casino in Havana, Cuba, during
the regime of BATISTA in Cuba, and is acquainted with
numerous Cubans in both Havana and Miami. *(X)u*

He has furnished insufficient information
to the present time to make it possible to evaluate his
reliability. *(X)u*

No further investigation is being conducted
in this matter by the Miami Office.
