From interviews with various members of the  
Asociacion de Veteranos de Bahia de Cochinos, Brigada 2506  
(AVBC) (Association of Veterans of the Bay of Pigs, Brigade 2506),  
it is apparent that the rank and file have no knowledge of  
certain activities of the organization; therefore, attempts  
are being made to develop one of the Executive Committee as  
a source of information in the organization of the father  
of BERNARDO DE TORRES. The [younger DE TORRES] has stated  
he would cooperate fully with the FBI in any matter, but
