Page 2, Paragraph 2, of San Antonio enclosure contains information concerning "EDWARDS." Miami sources do not know any such EDWARDS, but state the circumstances indicate EDWARDS is possibly ALEXANDER I. RORKE, JR. (Bufile 97-4623) (Miami 2-346).

For the information of San Antonio, RORKE, 29 years old, is a free lance photographer and newspaperman, and reportedly made several leaflet dropping flights over Cuba. On April 25, 1963, he participated in an aerial bombing mission over Havana, Cuba. On September 24, 1963, RORKE and pilot GEOFFREY F. SULLIVAN, in a rented Beechcraft Travelaire Airplane, Registration N6795T, left Florida, filed a flight plan for Belize, British Honduras, and were never heard from again. On October 2, 1963, a private search mission of nine persons in a DC-3 aircraft flew to Central America to look for RORKE. On October 6, 1963, the party returned, without success. CHARLES COLLIER of Dallas, Texas, paid for the mission, and was aboard this DC-3. COLLIER represented the insurance company which had insured the Beechcraft airplane flown by RORKE. *(S)(u)*

Miami associates and friends of RORKE now believe he is dead, and probably went down at sea in the airplane.

Indices of the Miami Office contain no information concerning FLOYD PARK, JR., or "EDWARDS," and Miami informants MM 639-S, MM 635-S, and MM 492-S, were contacted with negative results. *(S)(u)*
