On 5/9/63 SA W. HARLAN BROWN received, in person, a type-written report, dated 5/6/63, from DL-6-S. This report has been serialized as 134-1A-749. ~~(S)~~ (u)

Informant determined on 5/6/63 that on that date there was a regular CP meeting held in BILL LOWERY's car at the Lone Star Drive-inn. BILL LOWERY, AUGUSTIN ESTRADA and JOE LANDIN were present. ~~(S)~~ (u)

They discussed the Crystal City elections. LOWERY informed them that at the luncheon meeting that he attends, the Crystal City elections were discussed. J. O. GARCIA was present at that meeting. Someone suggested that he call United Press or Associated Press and ask that reporters be sent there. GARCIA's remarks, according to LOWERY, were that such a thing was useless - the Rangers would only beat them up. Some of those present, himself (LOWERY) included, stared at him in disbelief. LOWERY added that such a suggestion should have come from GARCIA himself - since it concerned his people. He was almost sure that RONNIE DUGGER, writer for the "Texas Observer" would be in Dallas Wednesday or Thursday. He was sure to make the Thursday luncheon, perhaps, then, they could learn more about the elections. ~~(S)~~ (u)

Informant determined ESTRADA then said he was not feeling too well and left for home. Before leaving he gave JOE LANDIN a papersack containing literature. This was what had been left after LOWERY and he had picked what they wanted. ~~(S)~~ (u)

After ESTRADA left, BILL LOWERY informed JOE LANDIN that two of the meetings he had with ESTRADA were sort of personal; they had discussed their problems at home. Concerning Crystal City, LOWERY reported that Attorney GEORGE SCHATZKE was to find out just what was really happening in Crystal City. LOWERY had proposed some action (by the luncheon group) to protect the Crystal City Latins from the Rangers. SCHATZKI said that first they would seek facts and figures. SCHATZKI also belongs to the ACLU. ~~(S)~~ (u)
