

AMERICAN UNDERGROUND Also Known As Minutemen Ft. Worth, Texas

The following information is supplemental to the information furnished in letterhead memorandum of October 28, 1965.

The following information was furnished on December 1, 1965, by Dallas T-1:

Dallas T-1 advised that on Thanksgiving evening, November 25, 1965, OTTO "DUKE" KOLING, an individual, who had in the past been associated with captioned organization, had been killed in a motorcycle accident at Ft. Worth, Texas.

Dallas T-l advised that he had not heard of any meetings held by the American Underground, and in his opinion the organization seemed to be dying out. He advised that as OTTO "DUKE" KOLING had been one of the main contacts in the organization, his recent death would be an additional reason for lack of activity by anyone who had in the past been associated with the group.
