indicating that the FPCC has taken any positive legal steps
to disband. However, it is to be noted that the FPCC
is merely a committee of the Institute for the Improvement
of Inter-American Relations, Incorporated, and that it is possible
that the FPCC could declare or consider itself disbanded without
taking any actual legal action, relying on the parent organization
to handle the necessary legal matters.
