2. FYI LATEST DEVELOPMENTS REF CASE. AT ARMATT REQUEST AND TO INSURE PROPER COORDINATION SWISS SIDE STATION CONTACTED INANITION (VIA INANITION 3) 8 NOVEMBER, BRIEFED INANITION RE SITUATION ASKED THEM AID ARMATT TO EXTENT POSSIBLE.

2. AFTERNOON 8 NOVEMBER INANITION 3 ADVISED STATION THAT INANITION CHECK REVEALED MEMO FROM CENTRAL POLICE BUREAU BERN RE SUBJ CASE EN ROUTE TO INANITIONS. CPB APPARENTLY CONSIDERS SUBJ CASE AS DELICATE MATTER AND IS SEEKING INANITION ADVICE RE HANDLING. ITEM PROBABLY WILL BE CONSIDERED BY INANITION 6 IN ABSENCE 1-20.

3. UPON RECEIPT REF B STATION INFORMED INANITION THAT POSSIBLE SUBJ REF USING NAME MICHAEL X. BOWERS WHILE TRAVELING IN SUISSE. ASA BACKGROUND OF BOWERS NOT MENTIONED.

4. ENTIRE AFFAIR BECAME MORE MYSTERIOUS WHEN WE RECEIVED RESULTS OF GNVA BASE CHECKS WITH INTANZAN 1 AND U.S. MISSION PERSONNEL OFFICER WHICH INDICATED THAT BOWERS WHO VISITED USIS

AND MISSION RESEMBLED AUDIE MURPHY, SHORT, NO GLASSES, NO MUSTACHE. DESCRIPTION OF DINKIN FROM ODIBEX AND NEWSMEN HE CONTACTED STATED HE HAD HEAVY BLACK MUSTACHE, VORE HORN RIM GLASSES. THUS APPEARS DINKIN NOT USING NAME AND ASA AFFILIATION OF BOWERS. QUESTION REMAINS WHO IS DOING SO AND FOR WHAT PURPOSE. WILL CONTINUE ADVISE DEVELOPMENTS.
