1. SYLVIA TIRADO DE DURAN AKA SYLVIA DE TIRADO, MEXICAN CITIZEN, WAS EMPLOYED BY CUBAN CONSULATE OFFICE MEXI AS TEMPORARY REPLACEMENT MARICARMEN CLIBARRI UPON LATTER'S DEATH JULY 63. DURAN WAS DIRECTOR MEXICAN-CUBAN INSTITUTE CULTURAL RELATIONS (IMCRC) UNTIL EARLY JAN 63 WHEN PRESSURED BY TERESA FROENZA TO RESIGN. (SEE MEXI 3035, 9 JAN 63)

2. BEFORE JULY 63, PER LIENVOY, DURAN HAD SPORADIC CONTACT CUBAN EMBASSY, MAINLY WITH FROENZA RE IMCRC MATTERS. FALL 62 HAD AFFAIR WITH CARLOS LECHUGA.
