1. MRS. UNSTAR REMAINING IN NASSAU WITH WIFE BRAZILIAN AMBASSADOR UNTIL RETURN HAVA CA 10 DEC. SHE NOT PLANNING COME MIAMI THIS TRIP AND IN VIEW PRESENCE WIFE BRAZILIAN AMBASSADOR UNLIKELY SHE WOULD AGREE CHANGE PLANS. BOTH WOMEN RETURNING HAVA ON SPECIAL FLIGHT CHARTERED BY WESTERN EMBASSIES HAVA AND ASSUME WOULD NOT WANT RUN RISK BEING STRANDED BY DELAYING RETURN.

2. AS INDICATED REF A, MRS. UNSTAR UNABLE PROVIDE ANY ADDITIONAL INFO. JENTONS QUERIED HER AT LENGTH BUT SATISFIED SHE HAS NO FURTHER KNOWLEDGE. THIS UNDERSTANDABLE SINCE SHE ONLY RELAYING INFO GIVEN HER BY UNSTAR.

3. JENTONS CURRENTLY ON LEAVE OUTSIDE WAVE AREA AND NOT AVAILABLE UNTIL 12 DEC. CONTACT WITH UNSTARS HAS BEEN MAINTAINED BY JENTONS LARGELY ON PERSONAL BASIS AND SINCE JENTONS ONLY WAVE STAFFER IN CONTACT WITH UNSTARS WOULD BE DIFFICULT CONTACT MRS UNSTAR ON CRASH BASIS. ALSO FEEL WOULD BE UNSOUND ATTEMPT HAVE MRS. UNSTAR CANCEL HER DEPARTURE AND REARRANGE SCHEDULE TO TRAVEL

MIAMI ONLY TO BE ASKED SAME QUESTIONS WHICH ALREADY PUT TO HER BY JENTONS.

4. WAVE HAS NO COMMO TO UNSTAR EXCEPT HIS POUCH WHICH HAVE USED IN PAST SEND BRIEF PERSONAL TYPE LETTERS FROM JENTONS. UNSTAR IN TURN HAS JENTONS HOME ADDRESS WHICH USES CORRESPOND WITH JENTONS, SENDING LETTERS VIA HIS POUCH TO MEXI AND THEN MAILING TO JENTONS ADDRESS.

5. JENTONS GAVE MRS. UNSTAR REQUEST FOR ALL ADDITIONAL DETAILS REF A REPORT AND ANTICIPATE THAT UNSTAR WILL SEND REPLY VIA NEXT POUCH SENT TO NASSAU WHICH SCHEDULED ARRIVE CA 12 DEC. IN LINE WITH PAST PRACTICE, UNSTAR WILL INSTRUCT COURIER MAIL HIS REPLY FROM NASSAU TO JENTONS. SHOULD UNSTAR HIMSELF COME OUT, WHICH NOT EXPECTED, JENTONS WILL MEET PERSONALLY.

6. WHILE FULLY SHARE HQS AND ODENVY DESIRE OBTAIN ALL DETAILS REF A REPORT SOONEST, BELIEVE APPROPRIATE KEEP IN MIND UNSTAR SEEMS HAVE TENDENCY REPORT SENSATIONAL TYPE INFO WHICH HAS NOT CHECKED OUT. FOR INSTANCE FALL 62 REPORTED IMPENDING REVOLT WHICH FAILED MATERIALIZE AND IN FEB 63 WIDESPREAD FORTHCOMING GOC PURGES WHICH LIKewise DID NOT TAKE PLACE (MEXI 3628).*
